EXCLUSIONS⁵

- Mechanical breakdowns covered by your vehicle's manufacturer's warranty.
- Mechanical breakdowns caused by accident, collision, vandalism, or weather-related conditions.
- Mechanical breakdowns caused by lack of maintenance or pre-existing conditions.
- For additional exclusions and limitations, please consult your Agreement.

1 Replacement parts for covered repairs will be replaced at the administrator's discretion using OEM (original equipment manufacturer) parts or like-kind and quality parts.

2 VSP coverage runs concurrently with any applicable manufacturer's warranties. In-Warranty coverage; tow vehicle coverage begins on the Agreement purchase date, mechanical breakdown coverage begins upon expiration of the manufacturer's warranty term and expiration is measured in time from the Agreement purchase date. Out-of-Warranty coverage; coverage begins on the Agreement purchase date and expiration is measured in time from the Agreement purchase date.
