

# THEFT PROTECTION

The Theft Protection Program<sup>1</sup> provides a theft-deterrent and identification system as well as a Limited Warranty to help minimize your losses.

## **BENEFITS**



#### **Deter**

Distinctive theft-warning decals used to deter theft



## **Identify**

Unit marked with identification codes



#### **Protect**

Up to a \$5,000 Limited Warranty Benefit<sup>2</sup> in the form of a credit towards a replacement unit at the original selling dealer,<sup>3</sup> if the theft protection product fails to prevent the theft of the unit and it is declared a total loss

### **HOW IT WORKS**

The following illustrates how the Theft Protection Limited Warranty Benefit can help cover replacement costs if your unit is stolen and declared a total loss.

Purchase price of replacement unit	\$10,000
Insurance proceeds from stolen unit	- \$7,000
Amount you owe	= \$3,000
Limited Warranty Benefit Credit	- \$3,000
Amount You Owe	\$0

The theft-deterrent product is permanently installed on the covered unit. Therefore, the Theft Protection program is non-cancelable.<sup>4</sup>

## **EXCLUSIONS**<sup>5</sup>

- Units stolen outside Canada, the United States, or its territories
- · Units stolen when unlocked or with the keys located on the unit
- Units stolen by family members or other people with access to the unit's keys
- 1 The Adventure Protect Theft Protection Program is not available for purchase in British Columbia.
- 2 If purchased as a pre-owned unit, the Limited Warranty Benefit will be the lesser of \$5,000 or the actual cash value of the unit on the date of loss.
- 3 The warranty benefit must be used as a credit toward the purchase/lease of a replacement unit at the original selling dealer within 6 months from the approval of the warranty benefit claim.
- 4 Please see your Warranty for complete cancellation rules, including province-specific cancellation rules.
